This letter is in response to the Resolution passed by the Carlsbad Irrigation District (CID) Board of Directors demanding a call for administration of priorities pursuant to Section 10 of the Settlement Agreement, dated March 25, 2003. The Pecos Valley Artesian Conservancy District (PVACD) as a party to the Settlement Agreement hereby makes formal demand that the PVACD be a participant in all discussions relating to the delivery of water under the Settlement Agreement, including matters related to the call for administration of priorities by the CID.

This letter will furthermore serve as formal notice that the PVACD asserts that the call for priorities by the CID presents no basis for the administration of priorities. The PVACD demands that the New Mexico State Engineer deny the CID's call for administration of priorities.
